



## **VENDOR/EXHIBITOR AGREEMENT**

Exhibitor agrees to hold The Pulmonary Hypertension Association, Taylor's Wish, The Race Committee, The City of Anaheim Fire Station #10, The City of Anaheim Traffic and Parks Departments, The City of Anaheim and Orange County where this event is held blameless, and to reimburse for any judgments, settlements, costs, or other expenses (including legal fees) to which they may be subject for any injury, damage, loss, or harm resulting from or occurring to anyone (including visitors) which may result directly from or in connection with such exhibit or the use of the rented space by the exhibitor, its employees or representatives.

**Liability:** Neither the Pulmonary Hypertension Association or Taylor's Wish or The City of Anaheim, the Officers thereof, its Vendor Chair, or other committee members or volunteers; will be responsible for any injury, loss, or damage that may arise to a Vendor, their employees, and/or their goods either while in transit to or from the event site, or while at the event site, from any cause whatsoever, and will not be liable for the fulfillment of this lease as to delivery of space beyond the Vendor Chair's control. Any complaints should be handled under the vendor's own liability insurance policy.

**Management Rights:** The Pulmonary Hypertension Association or Taylor's Wish reserves the right to restrict exhibits, which become objectionable because of noise, method of operation, materials, or in any way distract from the general character of The Pulmonary Hypertension Association or Taylor's Wish.

**Care of Event Site and Equipment:** Exhibitors or their representatives shall not injure or deface the walls, tables, or surrounding area. If such damage occurs, the exhibitor is liable to the owner of the property damaged.

**Use of Space:** All demonstrations or other promotional materials or activities shall be confined to the limits of the assigned exhibit space. If more space is needed, it may be purchased at additional cost.

**Security:** The exhibitor is solely responsible for his/her own exhibit material and should insure against loss or damage. All property of the exhibitor is understood to remain in his /her care, custody, and control in transit to and from, and within the confines of the exhibit area.

**Publicity:** The Pulmonary Hypertension Association or Taylor's Wish is authorized to use photographs and other media-denoting the exhibitor's participation in the conference in connection with publicity related to the event.
